Ann Moulds is an anti-stalking campaigner. In 2009, has launched the campaign Action Scotland Against Stalking, fighting for the recognition of stalking as a distinct and serious crime within Scots law. Scotland introduced pioneering stalking legislation, which made it a crime to cause a victim fear, alarm or distress.

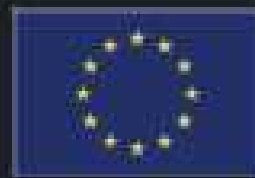
